2024/2025 Dockage, Valet Rack Service (VRS) & Storage Application

INDOOR VALET RACK SERVICE & WINTER STORAGE

Indoor Floor Storage Requires all Fall, Winter, & Spring Services to be Performed by Rex Marine

- Usually May Arrive Earlier For Winter Storage Than Contract Dates at No Extra Charge, Inquire for Details
- Indoor Summer Valet Rack Service: Sterndrive and Outboard Powered Boats up to 32' *LOA
- Additional Charges Applicable for Boats with Beam Larger than 8'6" or Height Over 10' Call/Email for Quote
- \$500 charge per additional registered user for shared-use boats. Charter/Revenue-generating use requires Rex Marine authorization.
- Absent Special Arrangements: Winter Floor Boats (unheated/VRS Building) will be launched or relocated outside by April 1, and may stay In-water at no charge for up to 3 days upon completion of Rex Marine Workorder.

OUTDOOR VALET RACK SERVICE & WINTER STORAGE

- Winter Outdoor Rate Applies to Rack Levels 2 and 3 Only. Land Rates Apply to Level 1 Boats.
- Summer Outdoor Valet Rack Service: Sterndrive and Outboard Powered Boats up to 42' *LOA, Levels 1 + 3, 25' Min
- \$500 charge per additional registered user for shared-use boats. Charter/Revenue-generating use requires Rex Marine authorization.

 Summer Valet Rack Service Details:
- One Launch & Haul Per Day
- Rinsing the Hull with Fresh Water when Hauled
- Outdoor Work Station Availability for Owner Maintenance
- Overnight Dockage Included, Inquire for Details
- Launch-on-Demand: No Advanced Notice Required
- Free BoatCloud App for Launch Requests
- Unload From/Load on Trailer, \$6/ft, by Appointment
- Minimum Charge Based on 18' Boat

DOCKAGE: SUMMER & WINTER

Minimum Charge Based on 24' *LOA

Winter Dockage / Wet Storage: \$50/ft, *LOA; minimum charge \$1,500. Electricity for boat use and de-icing equipment additional/metered. Arrival November 11 or later, must leave Rex Marine docks by March 30.

Summer Rate: 4/15/25 - 10/15/25 ... \$216/ft, Based on Larger of *LOA or min. slip size Includes \$25/ft credit towards Winter Storage.

- Metered Electricity Additional,
 - Charged at current electric company rate
- Clean Bathroom & Showers
- Free WiFi

- All Berths have Floating Docks

LAND STORAGE: SUMMER & WINTER

Summer Land Storage: 4/21/25 - 10/19/25 \$83.50 Per Foot *LOA Includes Haul, Block, Launch

THE FINE PRINT

- Note: Bottom Wash is required upon hauling (at extra cost) If fouling is evident, or if Rex is painting bottom
- *LOA = Length + Beam Over All. Outboard motors, swim platforms, anchor rollers/pulpits and other appendages increase LOA. LOA often exceeds the model length designated by the boat builder. LOA and Height is verified upon arrival.
- CONTRACT TERMS: Payment due in full upon boat arrival, or October 17 for Winter, April 21 for Summer, whichever occurs first. Account balance must be zero to reserve Storage, VRS, and Dockage. You may deduct 2% for full payment by check.
- MONTHLY RATES / Subject to Availability: Calculation Method for Contracts after Season has Started;
- Monthly Rate = Seasonal Rate/Four. Ex. One Month of Summer Indoor Rack (\$146/per foot divided by 4= \$36.50/Per Foot)
- 6.35% CT Sales Tax is additional only to Summer Rates above. Winter Storage is sales tax-exempt
